RESOLUTION

Amending the Rules of the House of Representatives to direct the Chief Administrative Officer to carry out an annual information security training program for Members, officers, and employees of the House.

1 *Resolved,*

2 **SECTION 1. SHORT TITLE.**

3 This resolution may be cited as the “Congressional

4 Cybersecurity Training Resolution of 2017”.

1 **SEC. 2. ANNUAL INFORMATION SECURITY TRAINING PRO-**
2 **GRAM FOR HOUSE MEMBERS, OFFICERS, AND**
3 **EMPLOYEES.**

4 Clause 4 of rule II of the Rules of the House of Rep-
5 resentatives is amended by adding at the end the following
6 new paragraph:

7 “(c)(1) The Chief Administrative Officer shall carry
8 out an annual information security training program for
9 Members (including the Delegates and Resident Commis-
10 sioner), officers, and employees of the House.

11 “(2) A new Member, Delegate, Resident Commis-
12 sioner, officer, or employee of the House shall receive
13 training under this paragraph not later than 30 days after
14 beginning service to the House.

15 “(3) Not later than January 31 of each year, each
16 officer and employee of the House shall file a certification
17 with the Chief Administrative Officer that the officer or
18 employee completed an information security training pro-
19 gram as established by this paragraph.”

RESOLUTION

Amending the Rules of the House of Representatives to prohibit with limited exceptions the participation of any Member, Delegate, Resident Commissioner, officer, or employee of the House on the board of any publicly held or publicly regulated corporation, financial institution, or business entity.

1 *Resolved,*

2 **SECTION 1. CONFLICT OF INTEREST.**

3 Rule XXV of the Rules of the House of Representa-
4 tives is amended by adding at the end the following new
5 clause:

1 **“Conflict of interest**

2 “9. A Member, Delegate, Resident Commissioner, of-
3 ficer, or employee of the House may not serve as an officer
4 or member of the board of any publicly held or publicly
5 regulated corporation, financial institution, or business en-
6 tity. The preceding sentence shall not apply to service of
7 a Member, Delegate, Resident Commissioner, officer, or
8 employee as—

9 “(a) an officer or member of the board of an organi-
10 zation which is exempt from taxation under section 501(c)
11 of the Internal Revenue Code of 1954, if such service is
12 performed without compensation; or

13 “(b) an officer or member of the board of an institu-
14 tion or organization which is principally available to Mem-
15 bers, Delegates, Resident Commissioner, officers, or em-
16 ployees of the House, or their families, if such service is
17 performed without compensation.”

18 **SEC. 2. EFFECTIVE DATE.**

19 The amendment made by section 1 of this resolution
20 shall take effect immediately before noon, January 3,
21 2019.
