## RESOLUTION

Providing for further consideration of the bill (H.R. 2740) making appropriations for the Departments of Labor, Health and Human Services, and Education, and related agencies for the fiscal year ending September 30, 2020, and for other purposes.

1       *Resolved*, That at any time after adoption of this reso-  
2 lution the Speaker may, pursuant to clause 2(b) of rule  
3 XVIII, declare the House resolved into the Committee of  
4 the Whole House on the state of the Union for further  
5 consideration of the bill (H.R. 2740) making appropria-

1 tions for the Departments of Labor, Health and Human  
2 Services, and Education, and related agencies for the fis-  
3 cal year ending September 30, 2020, and for other pur-  
4 poses.

5       SEC. 2. (a) No further amendment to the bill, as  
6 amended, shall be in order except those printed in the re-  
7 port of the Committee on Rules accompanying this resolu-  
8 tion, amendments en bloc described in section 3 of this  
9 resolution, and available pro forma amendments described  
10 in section 4 of House Resolution 431.

11       (b) Each further amendment printed in part A of the  
12 report of the Committee on Rules shall be considered only  
13 in the order printed in the report, may be offered only  
14 by a Member designated in the report, shall be considered  
15 as read, shall be debatable for the time specified in the  
16 report equally divided and controlled by the proponent and  
17 an opponent, may be withdrawn by the proponent at any  
18 time before action thereon, shall not be subject to amend-  
19 ment except amendments described in section 4 of House  
20 Resolution 431, and shall not be subject to a demand for  
21 division of the question in the House or in the Committee  
22 of the Whole.

23       (c) Each further amendment printed in part B of the  
24 report of the Committee on Rules may be offered at any  
25 time during the consideration of the bill for amendment,

1 may be offered only by a Member designated in the report,  
2 shall be considered as read, shall be debatable for the time  
3 specified in the report equally divided and controlled by  
4 the proponent and an opponent, may be withdrawn by the  
5 proponent at any time before action thereon, shall not be  
6 subject to amendment except amendments described in  
7 section 4 of House Resolution 431, and shall not be sub-  
8 ject to a demand for division of the question in the House  
9 or in the Committee of the Whole.

10 (d) All points of order against further amendments  
11 printed in the report of the Committee on Rules or against  
12 amendments en bloc described in section 3 of this resolu-  
13 tion are waived.

14 SEC. 3. It shall be in order at any time for the chair  
15 of the Committee on Appropriations or her designee to  
16 offer amendments en bloc consisting of further amend-  
17 ments printed in the report of the Committee on Rules  
18 accompanying this resolution not earlier disposed of.  
19 Amendments en bloc offered pursuant to this section shall  
20 be considered as read, shall be debatable for 20 minutes  
21 equally divided and controlled by the chair and ranking  
22 minority member of the Committee on Appropriations or  
23 their respective designees, shall not be subject to amend-  
24 ment except amendments described in section 4 of House  
25 Resolution 431, and shall not be subject to a demand for

1 division of the question in the House or in the Committee  
2 of the Whole.

3       SEC. 4. At the conclusion of consideration of the bill  
4 for amendment the Committee shall rise and report the  
5 bill, as amended, to the House with such further amend-  
6 ments as may have been adopted. The previous question  
7 shall be considered as ordered on the bill and amendments  
8 thereto to final passage without intervening motion except  
9 one motion to recommit with or without instructions.
