13. Provides that the amendment in the nature of a substitute recommended by the Committee on Oversight and Government Reform now printed in the bill shall be considered as adopted and the bill, as amended, shall be considered as read.

14. Waives all points of order against provisions in the bill, as amended.
15. Provides one hour of general debate equally divided and controlled by the chair and ranking minority member of the Committee on Oversight and Government Reform or their respective designees.
16. Provides one motion to recommit.
17. Closed rule for H.R. 7084.
18. Waives all points of order against consideration of the bill.
19. Provides that the amendment in the nature of a substitute recommended by the Committee on Transportation and Infrastructure now printed in the bill shall be considered as adopted and the bill, as amended, shall be considered as read.
20. Waives all points of order against provisions in the bill, as amended.
21. Provides one hour of general debate equally divided and controlled by the chair and ranking minority member of the Committee on Transportation and Infrastructure or their respective designees.
22. Provides one motion to recommit.
23. Provides that Section 8 of House Resolution 707, agreed to September 16, 2025, is amended by striking “March 31, 2026” and inserting “the remainder of the One Hundred Nineteenth Congress”.

RESOLUTION

Resolved, That upon adoption of this resolution it shall be in order to consider in the House the bill (H.R. 8029) making appropriations for the Department of Homeland Security for the fiscal year ending September 30, 2026, and for other purposes. All points of order against consideration of the bill are waived. The bill shall be considered as read. All points of order against provisions in the bill are waived. The previous question shall be considered as ordered on the bill and on any amendment thereto to final passage without intervening motion except: (1) one hour of debate equally divided and controlled by the chair and ranking minority member of the Committee on Appropriations or their respective designees; and (2) one motion to recommit.

Sec. 2. Upon adoption of this resolution it shall be in order without intervention of any point of order to consider in the House the resolution (H. Res. 1128) expressing the support of the House of Representatives for the Department of Homeland Security. The amendments to the resolution and the preamble printed in the report of the Committee on Rules accompanying this resolution shall be considered as adopted. The resolution, as amended, shall be

considered as read. The previous question shall be considered as ordered on the resolution and preamble, as amended, to adoption without intervening motion or demand for division of the question except one hour of debate equally divided and controlled by the chair and ranking minority member of the Committee on Homeland Security or their respective designees.

Sec. 3. Upon adoption of this resolution it shall be in order to consider in the House the bill (H.R. 5103) to establish a program to Beautify the District of Columbia and establish the District of Columbia Safe and Beautiful Commission. All points of order against consideration of the bill are waived. The amendment in the nature of a substitute recommended by the Committee on Oversight and Government Reform now printed in the bill shall be considered as adopted. The bill, as amended, shall be considered as read. All points of order against provisions in the bill, as amended, are waived. The previous question shall be considered as ordered on the bill, as amended, and on any further amendment thereto, to final passage without intervening motion except: (1) one hour of debate equally divided and controlled by the chair and ranking minority member of the Committee on Oversight and Government Reform or their respective designees; and (2) one motion to recommit.

Sec. 4. Upon adoption of this resolution it shall be in order to consider in the House the bill (H.R. 7084) to amend title 46, United States Code, with respect to the types of vessels that may enter or operate in navigable waters of the United States or transfer cargo in any port or place under the jurisdiction of the United States, and for other purposes. All points of order against consideration of the bill are waived. The amendment in the nature of a substitute recommended by the Committee on Transportation and Infrastructure now printed in the bill shall be considered as adopted. The bill, as amended, shall be considered as read. All points of order against provisions in the bill, as amended, are waived. The previous question shall be considered as ordered on the bill, as amended, and on any further amendment thereto, to final passage without intervening motion except: (1) one hour of debate equally divided and controlled by the chair and ranking minority member of the Committee on Transportation and Infrastructure or their respective designees; and (2) one motion to recommit.

Sec. 5. Section 8 of House Resolution 707, agreed to September 16, 2025, is amended by striking “March 31, 2026” and inserting “the remainder of the One Hundred Nineteenth Congress”.
