The Committee on Rules, having had under consideration House Resolution \_\_\_\_, by a record vote of 6 to 3, report the same to the House with the recommendation that the resolution be adopted.

SUMMARY OF PROVISIONS OF THE RESOLUTION

The resolution provides that the requirement of clause 6(a) of rule XIII for a two-thirds vote to consider a report from the Committee on Rules on the same day it is presented to the House is waived with respect to any resolution reported through the legislative day of June 5, 2026, relating to a measure providing for reconciliation pursuant to title II of S. Con. Res. 33.
