## **RESOLUTION**

Providing for consideration of the bill (H.R. 5055) making appropriations for energy and water development and related agencies for the fiscal year ending September 30, 2017, and for other purposes.

- 1 Resolved, That (a) at any time after adoption of this
- 2 resolution the Speaker may, pursuant to clause 2(b) of
- 3 rule XVIII, declare the House resolved into the Committee
- 4 of the Whole House on the state of the Union for consider-
- 5 ation of the bill (H.R. 5055) making appropriations for
- 6 energy and water development and related agencies for the

fiscal year ending September 30, 2017, and for other purposes. The first reading of the bill shall be dispensed with. 3 All points of order against consideration of the bill are 4 waived. General debate shall be confined to the bill and 5 shall not exceed one hour equally divided and controlled by the chair and ranking minority member of the Com-6 mittee on Appropriations. After general debate the bill 8 shall be considered for amendment under the five-minute rule. Points of order against provisions in the bill for failure to comply with clause 2 of rule XXI are waived. 10 11 (b) During consideration of the bill for amendment— 12 (1) each amendment, other than amendments 13 provided for in paragraph (2), shall be debatable for 14 10 minutes equally divided and controlled by the 15 proponent and an opponent; 16 (2) no pro forma amendment shall be in order 17 except that the chair and ranking minority member 18 of the Committee on Appropriations or their respec-19 tive designees may offer up to 10 pro forma amend-20 ments each at any point for the purpose of debate; 21 and 22 (3) the chair of the Committee of the Whole 23 may accord priority in recognition on the basis of 24 whether the Member offering an amendment has 25 caused it to be printed in the portion of the Con-

- 1 gressional Record designated for that purpose in
- 2 clause 8 of rule XVIII. Amendments so printed shall
- 3 be considered as read.
- 4 (c) When the committee rises and reports the bill
- 5 back to the House with a recommendation that the bill
- 6 do pass, the previous question shall be considered as or-
- 7 dered on the bill and amendments thereto to final passage
- 8 without intervening motion except one motion to recommit
- 9 with or without instructions.
- SEC. 2. Section 508 of H.R. 5055 shall be considered
- 11 to be a spending reduction account for purposes of section
- 12 3(d) of House Resolution 5.
- 13 Sec. 3. During consideration of H.R. 5055 pursuant
- 14 to this resolution, section 3304 of Senate Concurrent Res-
- 15 olution 11 shall not apply.
