Providing for consideration of the bill (H.R. 5485) making appropriations for financial services and general government for the fiscal year ending September 30, 2017, and for other purposes.

- 1 Resolved, That at any time after adoption of this reso-
- 2 lution the Speaker may, pursuant to clause 2(b) of rule
- 3 XVIII, declare the House resolved into the Committee of
- 4 the Whole House on the state of the Union for consider-
- 5 ation of the bill (H.R. 5485) making appropriations for
- 6 financial services and general government for the fiscal

- 1 year ending September 30, 2017, and for other purposes.
- 2 The first reading of the bill shall be dispensed with. All
- 3 points of order against consideration of the bill are waived.
- 4 General debate shall be confined to the bill and shall not
- 5 exceed one hour equally divided and controlled by the chair
- 6 and ranking minority member of the Committee on Appro-
- 7 priations.
- 8 Sec. 2. (a) After general debate the bill shall be con-
- 9 sidered for amendment under the five-minute rule. The bill
- 10 shall be considered as read through page 265, line 9.
- 11 Points of order against provisions in the bill for failure
- 12 to comply with clause 2 or clause 5(a) of rule XXI are
- 13 waived except as follows: beginning with ": Provided fur-
- 14 ther" on page 122, line 19, through "2012" on page 122,
- 15 line 22. Where points of order are waived against part
- 16 of a paragraph, points of order against a provision in an-
- 17 other part of such paragraph may be made only against
- 18 such provision and not against the entire paragraph.
- 19 (b) No amendment to the bill shall be in order except
- 20 those printed in the report of the Committee on Rules ac-
- 21 companying this resolution, amendments en bloc described
- 22 in section 3 of this resolution, and pro forma amendments
- 23 described in section 4 of this resolution.
- (c) Each amendment printed in the report of the
- 25 Committee on Rules shall be considered only in the order

- 1 printed in the report, may be offered only by a Member
- 2 designated in the report, shall be considered as read, shall
- 3 be debatable for the time specified in the report equally
- 4 divided and controlled by the proponent and an opponent,
- 5 shall not be subject to amendment except as provided by
- 6 section 4 of this resolution, and shall not be subject to
- 7 a demand for division of the question in the House or in
- 8 the Committee of the Whole.
- 9 (d) All points of order against amendments printed
- 10 in the report of the Committee on Rules or against amend-
- 11 ments en bloc described in section 3 of this resolution are
- 12 waived.
- 13 Sec. 3. It shall be in order at any time for the chair
- 14 of the Committee on Appropriations or his designee to
- 15 offer amendments en bloc consisting of amendments print-
- 16 ed in the report of the Committee on Rules accompanying
- 17 this resolution not earlier disposed of. Amendments en
- 18 bloc offered pursuant to this section shall be considered
- 19 as read, shall be debatable for 20 minutes equally divided
- 20 and controlled by the chair and ranking minority member
- 21 of the Committee on Appropriations or their respective
- 22 designees, shall not be subject to amendment except as
- 23 provided by section 4 of this resolution, and shall not be
- 24 subject to a demand for division of the question in the
- 25 House or in the Committee of the Whole.

- 1 Sec. 4. During consideration of the bill for amend-
- 2 ment, the chair and ranking minority member of the Com-
- 3 mittee on Appropriations or their respective designees may
- 4 offer up to 10 pro forma amendments each at any point
- 5 for the purpose of debate.
- 6 Sec. 5. At the conclusion of consideration of the bill
- 7 for amendment the Committee shall rise and report the
- 8 bill to the House with such amendments as may have been
- 9 adopted. The previous question shall be considered as or-
- 10 dered on the bill and amendments thereto to final passage
- 11 without intervening motion except one motion to recommit
- 12 with or without instructions.
- Sec. 6. Section 1201 of H.R. 5485 shall be consid-
- 14 ered to be a spending reduction account for purposes of
- 15 section 3(d) of House Resolution 5.
- 16 Sec. 7. During consideration of H.R. 5485, section
- 17 3304 of Senate Concurrent Resolution 11 shall not apply.
