Mr. SESSIONS, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 1) to provide for reconciliation pursuant to title II of the concurrent resolution on the budget for fiscal year 2018, and providing for proceedings during the period from November 17, 2017, through November 27, 2017.

- 1 *Resolved*, That upon adoption of this resolution it
- 2 shall be in order to consider in the House the bill (H.R.
- 3 1) to provide for reconciliation pursuant to title II of the
- 4 concurrent resolution on the budget for fiscal year 2018.
- 5 All points of order against consideration of the bill are
- 6 waived. In lieu of the amendment in the nature of a sub-

1 stitute recommended by the Committee on Ways and
2 Means now printed in the bill, an amendment in the na-
3 ture of a substitute consisting of the text of Rules Com-
4 mittee Print 115-39 shall be considered as adopted. The
5 bill, as amended, shall be considered as read. All points
6 of order against provisions in the bill, as amended, are
7 waived. The previous question shall be considered as or-
8 dered on the bill, as amended, and on any further amend-
9 ment thereto, to final passage without intervening motion
10 except: (1) four hours of debate equally divided and con-
11 trolled by the chair and ranking minority member of the
12 Committee on Ways and Means; and (2) one motion to
13 recommit with or without instructions. Clause 5(b) of rule
14 XXI shall not apply to the bill or amendments thereto.

15 SEC. 2. Upon passage of H.R. 1, the amendment to
16 the title of such bill recommended by the Committee on
17 Ways and Means now printed in the bill shall be consid-
18 ered as adopted.

19 SEC. 3. On any legislative day during the period from
20 November 17, 2017, through November 27, 2017—

21 (a) the Journal of the proceedings of the previous day
22 shall be considered as approved; and

23 (b) the Chair may at any time declare the House ad-
24 journed to meet at a date and time, within the limits of

1 clause 4, section 5, article I of the Constitution, to be an-
2 nounced by the Chair in declaring the adjournment.

3 SEC. 4. The Speaker may appoint Members to per-
4 form the duties of the Chair for the duration of the period
5 addressed by section 3 of this resolution as though under
6 clause 8(a) of rule I.
