RESOLUTION

Providing for consideration of the bill (H.R. 4061) to amend the Financial Stability Act of 2010 to improve the transparency of the Financial Stability Oversight Council, to improve the SIFI designation process, and for other purposes, and providing for consideration of the bill (H.R. 4293) to reform the Comprehensive Capital Analysis and Review process, the Dodd-Frank Act Stress Test process, and for other purposes.

1 *Resolved*, That upon adoption of this resolution it
2 shall be in order to consider in the House the bill (H.R.
3 4061) to amend the Financial Stability Act of 2010 to
4 improve the transparency of the Financial Stability Over-
5 sight Council, to improve the SIFI designation process,
6 and for other purposes. All points of order against consid-
7 eration of the bill are waived. An amendment in the nature
8 of a substitute consisting of the text of Rules Committee
9 Print 115-64, modified by the amendment printed in part
10 A of the report of the Committee on Rules accompanying
11 this resolution, shall be considered as adopted. The bill,
12 as amended, shall be considered as read. All points of
13 order against provisions in the bill, as amended, are
14 waived. The previous question shall be considered as or-
15 dered on the bill, as amended, and on any further amend-
16 ment thereto, to final passage without intervening motion
17 except: (1) one hour of debate equally divided and con-
18 trolled by the chair and ranking minority member of the
19 Committee on Financial Services; and (2) one motion to
20 recommit with or without instructions.

21 SEC. 2. Upon adoption of this resolution it shall be
22 in order to consider in the House the bill (H.R. 4293)
23 to reform the Comprehensive Capital Analysis and Review
24 process, the Dodd-Frank Act Stress Test process, and for
25 other purposes. All points of order against consideration

1 of the bill are waived. In lieu of the amendment in the
2 nature of a substitute recommended by the Committee on
3 Financial Services now printed in the bill, an amendment
4 in the nature of a substitute consisting of the text of Rules
5 Committee Print 115-63, modified by the amendment
6 printed in part B of the report of the Committee on Rules
7 accompanying this resolution, shall be considered as
8 adopted. The bill, as amended, shall be considered as read.
9 All points of order against provisions in the bill, as amend-
10 ed, are waived. The previous question shall be considered
11 as ordered on the bill, as amended, and on any further
12 amendment thereto, to final passage without intervening
13 motion except: (1) one hour of debate equally divided and
14 controlled by the chair and ranking minority member of
15 the Committee on Financial Services; and (2) one motion
16 to recommit with or without instructions.
