1 *Resolved*, That upon adoption of this resolution it 2 shall be in order to consider in the House the bill (H.R. 3 4061) to amend the Financial Stability Act of 2010 to 4 improve the transparency of the Financial Stability Over-5 sight Council, to improve the SIFI designation process, and for other purposes. All points of order against consid-6 7 eration of the bill are waived. An amendment in the nature 8 of a substitute consisting of the text of Rules Committee 9 Print 115-64, modified by the amendment printed in part 10 A of the report of the Committee on Rules accompanying this resolution, shall be considered as adopted. The bill, 11 as amended, shall be considered as read. All points of 12 13 order against provisions in the bill, as amended, are waived. The previous question shall be considered as or-14 15 dered on the bill, as amended, and on any further amendment thereto, to final passage without intervening motion 16 except: (1) one hour of debate equally divided and con-17 18 trolled by the chair and ranking minority member of the Committee on Financial Services; and (2) one motion to 19 recommit with or without instructions. 20

in order to consider in the House the bill (H.R. 4293)

other purposes. All points of order against consideration

In lieu of the amendment in the 2 nature of a substitute recommended by the Committee on Financial Services now printed in the bill, an amendment 3 4 in the nature of a substitute consisting of the text of Rules Committee Print 115-63, modified by the amendment 5 6 printed in part B of the report of the Committee on Rules 7 accompanying this resolution, shall be considered as 8 adopted. The bill, as amended, shall be considered as read. 9 All points of order against provisions in the bill, as amended, are waived. The previous question shall be considered 10 11 as ordered on the bill, as amended, and on any further 12 amendment thereto, to final passage without intervening 13 motion except: (1) one hour of debate equally divided and controlled by the chair and ranking minority member of 14 15 the Committee on Financial Services; and (2) one motion to recommit with or without instructions. 16
