RESOLUTION

Res. 75) making further continuing appropriations for the fiscal year ending September 30, 2022, and for other purposes;

providing for consideration of the bill (H.R. 6968) to prohibit the importation of energy products of the Russian Federation, and for other purposes; and providing for consideration of the bill (H.R. 7007) making emergency supplemental appropriations for coronavirus response and relief for the fiscal year ending September 30, 2022, and for other purposes.

1 *Resolved*, That upon adoption of this resolution it 2 shall be in order to take from the Speaker's table the bill (H.R. 2471) to measure the progress of post-disaster re-3 covery and efforts to address corruption, governance, rule 4 5 of law, and media freedoms in Haiti, with the Senate amendment thereto, and to consider in the House, without 6 7 intervention of any point of order, a motion offered by the 8 chair of the Committee on Appropriations or her designee 9 that the House concur in the Senate amendment with an 10 amendment consisting of the text of Rules Committee 11 Print 117-35 modified by the amendment printed in the 12 report of the Committee on Rules accompanying this reso-13 lution. The Senate amendment and the motion shall be considered as read. The motion shall be debatable for one 14 hour equally divided and controlled by the chair and rank-15 ing minority member of the Committee on Appropriations 16 17 or their respective designees. The previous question shall be considered as ordered on the motion to its adoption 18 19 without intervening motion. The question of adoption of 20 the motion shall be divided for a separate vote on all of Z:\XML\XML_158.XML

the matter proposed to be inserted by the amendment of
the House other than divisions B, C, F, X, and Z, and
titles 2 and 3 of division N. The two portions of the di vided question shall be considered in the order specified
by the Chair. If either portion of the divided question fails
of adoption, then the House shall be considered to have
made no disposition of the Senate amendment.

8 SEC. 2. The chair of the Committee on Appropria-9 tions and the chair of the Permanent Select Committee 10 on Intelligence may insert in the Congressional Record not 11 later than March 11, 2022, such material as they may 12 deem explanatory of the Senate amendment and the mo-13 tion specified in the first section of this resolution.

14 SEC. 3. Upon adoption of this resolution it shall be 15 in order to consider in the House the joint resolution (H.J. Res. 75) making further continuing appropriations for the 16 17 fiscal year ending September 30, 2022, and for other purposes. All points of order against consideration of the joint 18 19 resolution are waived. The joint resolution shall be consid-20 ered as read. All points of order against provisions in the 21 joint resolution are waived. The previous question shall be considered as ordered on the joint resolution and on any 22 23 amendment thereto to final passage without intervening 24 motion except: (1) one hour of debate equally divided and 25 controlled by the chair and ranking minority member of Z:\XML\XML_158.XML

the Committee on Appropriations or their respective des ignees; and (2) one motion to recommit.

3 SEC. 4. Upon adoption of this resolution it shall be 4 in order to consider in the House the bill (H.R. 6968) 5 to prohibit the importation of energy products of the Russian Federation, and for other purposes. All points of 6 7 order against consideration of the bill are waived. The bill 8 shall be considered as read. All points of order against 9 provisions in the bill are waived. The previous question 10 shall be considered as ordered on the bill and on any amendment thereto to final passage without intervening 11 12 motion except: (1) one hour of debate equally divided and 13 controlled by the chair and ranking minority member of the Committee on Ways and Means or their respective des-14 15 ignees; and (2) one motion to recommit.

16 SEC. 5. Upon adoption of this resolution it shall be in order to consider in the House the bill (H.R. 7007) 17 18 making emergency supplemental appropriations for 19 coronavirus response and relief for the fiscal year ending 20September 30, 2022, and for other purposes. All points 21 of order against consideration of the bill are waived. The 22 bill shall be considered as read. All points of order against 23 provisions in the bill are waived. The previous question 24 shall be considered as ordered on the bill and on any 25 amendment thereto to final passage without intervening
