RESOLUTION

Providing for consideration of the bill (S. 1383) to establish the Veterans Advisory Committee on Equal Access, and for other purposes; providing for consideration of the bill (H.R. 2189) to modernize Federal firearms laws

to account for advancements in technology and less-than-lethal weapons, and for other purposes; providing for consideration of the bill (H.R. 261) to amend the National Marine Sanctuaries Act to prohibit requiring an authorization for the installation, continued presence, operation, maintenance, repair, or recovery of undersea fiber optic cables in a national marine sanctuary if such activities have previously been authorized by a Federal or State agency; providing for consideration of the bill (H.R. 3617) to amend the Department of Energy Organization Act to secure the supply of critical energy resources, including critical minerals and other materials, and for other purposes; and waiving a requirement of clause 6(a) of rule XIII with respect to consideration of certain resolutions reported from the Committee on Rules.

1 *Resolved*, That upon adoption of this resolution it
2 shall be in order to consider in the House the bill (S.
3 1383) to establish the Veterans Advisory Committee on
4 Equal Access, and for other purposes. All points of order
5 against consideration of the bill are waived. An amend-
6 ment in the nature of a substitute consisting of the text
7 of Rules Committee Print 119–19, modified by the amend-
8 ment printed in the report of the Committee on Rules ac-
9 companying this resolution, shall be considered as adopt-
10 ed. The bill, as amended, shall be considered as read. All
11 points of order against provisions in the bill, as amended,
12 are waived. The previous question shall be considered as
13 ordered on the bill, as amended, and on any further

1 amendment thereto, to final passage without intervening
2 motion except: (1) one hour of debate equally divided and
3 controlled by the chair and ranking minority member of
4 the Committee on House Administration or their respec-
5 tive designees; and (2) one motion to commit.

6 SEC. 2. Upon adoption of this resolution it shall be
7 in order to consider in the House the bill (H.R. 2189)
8 to modernize Federal firearms laws to account for ad-
9 vancements in technology and less-than-lethal weapons,
10 and for other purposes. All points of order against consid-
11 eration of the bill are waived. In lieu of the amendment
12 in the nature of a substitute recommended by the Com-
13 mittee on the Judiciary now printed in the bill, an amend-
14 ment in the nature of a substitute consisting of the text
15 of Rules Committee Print 119–18 shall be considered as
16 adopted. The bill, as amended, shall be considered as read.
17 All points of order against provisions in the bill, as amend-
18 ed, are waived. The previous question shall be considered
19 as ordered on the bill, as amended, and on any further
20 amendment thereto, to final passage without intervening
21 motion except: (1) one hour of debate equally divided
22 among and controlled by the chair and ranking minority
23 member of the Committee on the Judiciary or their respec-
24 tive designees and the chair and ranking minority member

1 of the Committee on Ways and Means or their respective
2 designees; and (2) one motion to recommit.

3 SEC. 3. Upon adoption of this resolution it shall be
4 in order to consider in the House the bill (H.R. 261) to
5 amend the National Marine Sanctuaries Act to prohibit
6 requiring an authorization for the installation, continued
7 presence, operation, maintenance, repair, or recovery of
8 undersea fiber optic cables in a national marine sanctuary
9 if such activities have previously been authorized by a Fed-
10 eral or State agency. All points of order against consider-
11 ation of the bill are waived. The amendment in the nature
12 of a substitute recommended by the Committee on Natural
13 Resources now printed in the bill shall be considered as
14 adopted. The bill, as amended, shall be considered as read.
15 All points of order against provisions in the bill, as amend-
16 ed, are waived. The previous question shall be considered
17 as ordered on the bill, as amended, and on any further
18 amendment thereto, to final passage without intervening
19 motion except: (1) one hour of debate equally divided and
20 controlled by the chair and ranking minority member of
21 the Committee on Natural Resources or their respective
22 designees; and (2) one motion to recommit.

23 SEC. 4. Upon adoption of this resolution it shall be
24 in order to consider in the House the bill (H.R. 3617)
25 to amend the Department of Energy Organization Act to

1 secure the supply of critical energy resources, including
2 critical minerals and other materials, and for other pur-
3 poses. All points of order against consideration of the bill
4 are waived. The amendment in the nature of a substitute
5 recommended by the Committee on Energy and Commerce
6 now printed in the bill shall be considered as adopted. The
7 bill, as amended, shall be considered as read. All points
8 of order against provisions in the bill, as amended, are
9 waived. The previous question shall be considered as or-
10 dered on the bill, as amended, and on any further amend-
11 ment thereto, to final passage without intervening motion
12 except: (1) one hour of debate equally divided and con-
13 trolled by the chair and ranking minority member of the
14 Committee on Energy and Commerce or their respective
15 designees; and (2) one motion to recommit.

16 SEC. 5. The requirement of clause 6(a) of rule XIII
17 for a two-thirds vote to consider a report from the Com-
18 mittee on Rules on the same day it is presented to the
19 House is waived with respect to any resolution reported
20 through the legislative day of February 13, 2026, relating
21 to a measure continuing appropriations for the fiscal year
22 ending September 30, 2026.
