

In the Senate of the United States,

July 17 (legislative day, July 16), 2025.

Resolved, That the bill from the House of Representatives (H.R. 4) entitled “An Act to rescind certain budget authority proposed to be rescinded in special messages transmitted to the Congress by the President on June 3, 2025, in accordance with section 1012(a) of the Congressional Budget and Impoundment Control Act of 1974.”, do pass with the following

AMENDMENT:

Strike all after the enacting clause and insert the following:

1 ***SECTION 1. SHORT TITLE.***

2 *This Act may be cited as the “Rescissions Act of 2025”.*

3 ***SEC. 2. RESCISSIONS OF BUDGET AUTHORITY.***

4 *(a) IN GENERAL.—Pursuant to the special message*
5 *transmitted by the President on June 3, 2025, to the House*
6 *of Representatives and the Senate proposing the rescission*
7 *of budget authority under section 1012 of part B of title*
8 *X of the Congressional Budget and Impoundment Control*

1 *Act of 1974 (2 U.S.C. 682 et seq.), the rescissions described*
 2 *under subsection (b) shall take effect immediately upon the*
 3 *date of enactment of this Act.*

4 *(b) RESCISSIONS.—The rescissions described in this*
 5 *subsection are as follows:*

 15 *vided further, That the preceding proviso does not*
 16 *apply to family planning and reproductive health*

AMENDMENT
