**RESOLUTION**

Providing for consideration of the bill (H.R. 4992) to codify regulations relating to transfers of funds involving Iran, and for other purposes; providing for consideration of the bill (H.R. 5119) to prohibit the obligation or expenditure of funds available to any Federal department or agency for any fiscal year to purchase or issue a license for the purchase of heavy water produced in Iran; and providing for consideration of the bill (H.R. 5631) to

hold Iran accountable for its state sponsorship of terrorism and other threatening activities and for its human rights abuses, and for other purposes.

1       *Resolved*, That upon adoption of this resolution it  
2 shall be in order to consider in the House the bill (H.R.  
3 4992) to codify regulations relating to transfers of funds  
4 involving Iran, and for other purposes. All points of order  
5 against consideration of the bill are waived. The bill shall  
6 be considered as read. All points of order against provi-  
7 sions in the bill are waived. The previous question shall  
8 be considered as ordered on the bill and on any amend-  
9 ment thereto to final passage without intervening motion  
10 except: (1) one hour of debate equally divided and con-  
11 trolled by the chair and ranking minority member of the  
12 Committee on Financial Services; and (2) one motion to  
13 recommit.

14       SEC. 2. Upon adoption of this resolution it shall be  
15 in order to consider in the House the bill (H.R. 5119)  
16 to prohibit the obligation or expenditure of funds available  
17 to any Federal department or agency for any fiscal year  
18 to purchase or issue a license for the purchase of heavy  
19 water produced in Iran. All points of order against consid-  
20 eration of the bill are waived. The bill shall be considered  
21 as read. All points of order against provisions in the bill  
22 are waived. The previous question shall be considered as  
23 ordered on the bill and on any amendment thereto to final

1 passage without intervening motion except: (1) one hour  
2 of debate equally divided and controlled by the chair and  
3 ranking minority member of the Committee on Foreign  
4 Affairs; and (2) one motion to recommit.
