Res. 3) setting forth the congressional budget for the United States Government for fiscal year 2017 and setting forth the appropriate budgetary levels for fiscal years 2018 through 2026, and providing for consideration of the bill (S. 84) to provide for an exception to a limitation against appointment of persons as Secretary of Defense within seven years of relief from active duty as a regular commissioned officer of the Armed Forces.

Mr. WOODALL, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the concurrent resolution (S. Con. Res. 3) setting forth the congressional budget for the United States Government for fiscal year 2017 and setting forth the appropriate budgetary levels for fiscal years 2018 through 2026, and providing for consideration of the bill (S. 84) to provide for an exception to a limitation against appointment of persons as Secretary of Defense within seven years of relief from active duty as a regular commissioned officer of the Armed Forces.

1 *Resolved*, That at any time after adoption of this reso-2 lution the Speaker may, pursuant to clause 2(b) of rule 3 XVIII, declare the House resolved into the Committee of the Whole House on the state of the Union for consider-4 5 ation of the concurrent resolution (S. Con. Res. 3) setting forth the congressional budget for the United States Gov-6 7 ernment for fiscal year 2017 and setting forth the appro-8 priate budgetary levels for fiscal years 2018 through 2026. 9 The first reading of the concurrent resolution shall be dispensed with. All points of order against consideration of 10 11 the concurrent resolution are waived. General debate shall not exceed two hours, with 90 minutes of general debate 12 13 confined to the congressional budget equally divided and 14 controlled by the chair and ranking minority member of the Committee on the Budget and 30 minutes of general 15 16 debate on the subject of economic goals and policies equally divided and controlled by Representative Tiberi of Ohio 17 18 and Representative Carolyn Maloney of New York or their respective designees. After general debate the concurrent 19 20 resolution shall be considered for amendment under the five-minute rule. The concurrent resolution shall be con-21 22 sidered as read. No amendment shall be in order except 23 the amendment printed in the report of the Committee on Rules accompanying this resolution. Such amendment 24

may be offered only by the Member designated in the re-1 port, shall be considered as read, and shall be debatable 2 3 for the time specified in the report equally divided and 4 controlled by the proponent and an opponent. All points 5 of order against such amendment are waived. After the conclusion of consideration of the concurrent resolution 6 7 for amendment, the Committee shall rise and report the concurrent resolution to the House with such amendment 8 9 as may have been adopted. The previous question shall 10 be considered as ordered on the concurrent resolution and on any amendment thereto to adoption without inter-11 12 vening motion. The concurrent resolution shall not be subject to a demand for division of the question of its adop-13 tion. 14

15 SEC. 2. Upon adoption of this resolution it shall be in order to consider in the House the bill (S. 84) to provide 16 for an exception to a limitation against appointment of 17 persons as Secretary of Defense within seven years of re-18 lief from active duty as a regular commissioned officer of 19 the Armed Forces. All points of order against consider-20 21 ation of the bill are waived. The bill shall be considered 22 as read. All points of order against provisions in the bill 23 are waived. The previous question shall be considered as 24 ordered on the bill and on any amendment thereto to final 25 passage without intervening motion except: (1) 90 minutes

1 of debate equally divided and controlled by the chair and

- 2 ranking minority member of the Committee on Armed
- 3 Services; and (2) one motion to commit.
