6	"(C) The term 'toxic exposure risk activity'
7	means any activity—
8	"(i) that requires a corresponding entry in
9	an exposure tracking record system (as defined

13	fies for purposes of this subsection when taking

15	tect the health of veterans.".

10	(2) Phase in.—Such subsection is further

18	in subparagraph (A) to an earlier date, as the Secretary
19	determines appropriate based on the number of veterans
20	receiving hospital care, medical services, and nursing home
21	care under subparagraphs (G), (H), and (I) of paragraph
22	(1) and the resources available to the Secretary.
23	"(ii) If the Secretary determines to modify a date
24	under clause (i), the Secretary shall—

1	"(I) notify the Committee on Veterans' Affairs
2	of the Senate and the Committee on Veterans' Af-
3	fairs of the House of Representatives of the pro-
4	posed modification; and
5	"(II) publish such modified date in the Federal
6	Register.".
7	(b) Outreach Plans.—With respect to each of

9	38, United States Code (as added by subsection (a)(2)),
10	not later than 180 days before the date specified in the
11	clause (including a date modified pursuant to such sec-
12	tion), the Secretary shall submit to the Committee on Vet-
13	erans' Affairs of the Senate and the Committee on Vet-
14	erans' Affairs of the House of Representatives a plan to
15	conduct outreach to the veterans described in the clause
16	to notify such veterans of their eligibility for hospital care,

1	(1) complete an assessment to determine—
2	(A) the personnel and material resources
3	necessary to implement section 103 (including
4	the amendments made by such section); and
5	(B) the total number of covered veterans,
6	as such term is defined in section 1119(c) of
7	title 38, United States Code (as added by sec-
8	tion 302), who receive hospital care or medical
9	services furnished by the Secretary under chap-
10	ter 17 of such title, disaggregated by priority
11	group specified in section 1705(a) of such title;
12	and
13	(2) submit to the Committee on Veterans' Af-
14	fairs of the Senate and the Committee on Veterans'
15	Affairs of the House of Representatives a report
16	containing the findings of the assessment completed
17	under paragraph (1), including a specific determina-
18	tion as to whether the Department has the personnel
19	and material resources necessary to implement sec-
20	tion 103.
21	(b) Information Systems.—Not later than October
22	1, 2024, the Secretary shall establish information systems
23	to assess the implementation of section 103, including the
24	amendments made by such section, and use the results

of assessments under such systems to inform the reports under subsection (c). 3 (c) Annual Reports.— 4 (1) Reports.—Not later than October 1, 2025, 5 and on an annual basis thereafter until October 1, 6 2033, the Secretary shall submit to the Committee 7 on Veterans' Affairs of the Senate and the Com-8 mittee on Veterans' Affairs of the House of Rep-9 resentatives a report on the following: 10 (A) The effect of the implementation of, 11 and the provision and management of care 12 under, section 103 (including the amendments 13 made by such section) on the demand by vet-14 erans described in subparagraphs (G), (H), and 15 (I) of section 1710(e)(1) of title 38, United 16 States Code (as added by such section 103) for 17 health care services furnished by the Secretary. 18 (B) Any differing patterns of demand for 19 health care services by such veterans, 20 disaggregated by factors such as the relative 21 distance of the veteran from medical facilities of 22 the Department and whether the veteran had 23 previously received hospital care or medical 24 services furnished by the Secretary under chap-25 ter 17 of such title.

3	(D) Any changes, during the year covered
4	by the report, in the delivery patterns of health
5	care furnished by the Secretary under chapter
6	17 of such title, and the fiscal impact of such
7	changes.
8	(2) Matters.—Each report under paragraph
9	(1) shall include, with respect to the year covered by
10	the report, detailed information on the following:
11	(A) The total number of veterans enrolled
12	in the patient enrollment system who, during
13	such year, received hospital care or medical
14	services furnished by the Secretary under chap-
15	ter 17 of title 38, United States Code.
16	(B) Of the veterans specified in subpara-
17	graph (A), the number of such veterans who,
18	during the preceding three fiscal years, had not
19	received such care or services.
20	(C) With respect to the veterans specified
21	in subparagraph (B), the cost of providing
22	health care to such veterans during the year
23	covered by the report, shown in total and
24	disaggregated by—
25	(i) the level of care; and

1	(ii) whether the care was provided
2	through the Veterans Community Care
3	Program.
4	(D) With respect to the number of vet-
5	erans described in subparagraphs (G), (H), and
6	(I) of section 1710(e)(1) of title 38, United
7	States Code (as added by section 103), the fol-
8	lowing (shown in total and disaggregated by
9	medical facility of the Department, as applica-
10	ble):
11	(i) The number of such veterans who,
12	during the year covered by the report, en-
13	rolled in the patient enrollment system.
14	(ii) The number of such veterans who
15	applied for, but were denied, such enroll-
16	ment.
17	(iii) The number of such veterans who
18	were denied hospital care or a medical
19	service furnished by the Secretary that was
20	considered to be medically necessary but
21	not of an emergency nature.
22	(E) The numbers and characteristics of,
23	and the type and extent of health care fur-
24	nished by the Secretary to, veterans enrolled in
25	the patient enrollment system (shown in total

1	and disaggregated by medical facility of the De-
2	partment).
3	(F) The numbers and characteristics of,
4	and the type and extent of health care fur-
5	nished by the Secretary to, veterans not en-
6	rolled in the patient enrollment system
7	(disaggregated by each class of eligibility for
8	care under section 1710 of title 38, United
9	States Code, and further shown as a total per
10	class and disaggregated by medical facility of
11	the Department).
12	(G) The specific fiscal impact (shown in
13	total and disaggregated by geographic health
14	care delivery areas) of changes in the delivery
15	patterns of health care furnished by the Sec-
16	retary under chapter 17 of such title as a result
17	of the implementation of section 103 (including
18	the amendments made by such section).
19	(d) Definitions.—In this section:
20	(1) Patient enrollment system.—The term
21	"patient enrollment system" means the patient en-
22	rollment system of the Department of Veterans Af-

12	"(A) the Secretary provides—
13	"(i) public notice regarding what for-
14	mal evaluations the Secretary plans to con-
15	duct; and
16	"(ii) the public an opportunity to com-
17	ment on the proposed formal evaluations;
18	"(B) the working group established under
19	subsection (b) of such section provides—
20	"(i) advice to the Secretary on toxic-
21	exposed veterans and cases in which vet-
22	erans who, during active military, naval,
23	air, or space service, may have experienced
24	a toxic exposure or their dependents may
25	have experienced a toxic exposure while the

3	"(ii) recommendations to the Sec-
4	retary on corrections needed in the Indi-

8	"(iii) recommendations to the Sec-
9	retary regarding which cases of possible
10	toxic exposure should be reviewed;
11	"(2) the Secretary provides for formal evalua-
12	tions of such recommendations under section 1173
13	of this title and takes into account reports received
14	by the Secretary from the National Academies of
15	Sciences, Engineering, and Medicine under section
16	1176 of this title; and
17	"(3) the Secretary issues regulations under sec-
18	tion 1174 of this title.
19	"(b) Definitions.—In this subchapter:
20	"(1) The term 'illness' includes a disease or
21	other condition affecting the health of an individual,
22	including mental and physical health.
23	"(2) The term 'Individual Longitudinal Expo-

4	"(2) An incentive provided to an employee under
5	paragraph (1) may not to exceed 25 percent of the basic
6	pay of the employee.
7	"(3) Provision of an incentive under paragraph (1)
8	shall be contingent on the employee entering into a written
9	agreement to complete a period of employment with the
10	Department.
11	"(4) An incentive provided under paragraph (1) shall
12	not be considered basic pay for any purpose.
13	"(5) The Secretary may prescribe conditions, includ-
14	ing with respect to eligibility, and limitations on provision
15	of incentive under paragraph (1).
16	"(6) Incentive provided under paragraph (1) shall not
17	be included in the calculation of total amount of com-
18	pensation under section 7431(e)(4) of this title.
19	"(e) Student Loan Repayments.—(1) Subject to
20	the provisions of this subsection, the Secretary may repay
21	a student loan pursuant to section 5379(b) of title 5.
22	"(2) Paragraph (2) of such section shall not apply
23	to payment under this subsection.
24	"(3) Payment under this subsection shall be made

25 subject to such terms, limitations, or conditions as may

- 1 be mutually agreed to by the Secretary and the employee
- 2 concerned, except that the amount paid by the Secretary
- 3 under this subsection may not exceed—
- 4 "(A) \$40,000 for any employee in any calendar
- 5 year; or
- 6 "(B) a total of \$100,000 in the case of any em-
- 7 ployee.
- 8 "(f) Expedited Hiring Authority for College
- 9 Graduates; Competitive Service.—(1) Subject to
- 10 paragraph (2) of this subsection, the Secretary may expe-
- 11 dite hiring for college graduates under section 3115 of
- 12 title 5 without regard to subsection (e) of such section or
- 13 any regulations prescribed by the Office of Personnel
- 14 Management for administration of such subsection.
- 15 "(2) The number of employees the Secretary may ap-
- 16 point under section 3115 of title 5 may not exceed the
- 17 number equal to 25 percent of individuals that the Sec-
- 18 retary appointed during the previous fiscal year to a posi-
- 19 tion in the competitive service classified in a professional
- 20 or administrative occupational category, at the GS-11
- 21 level, or an equivalent level, or below, under a competitive
- 22 examining procedure.
- 23 "(g) Expedited Hiring Authority for Post-
- 24 SECONDARY STUDENTS; COMPETITIVE SERVICE.—(1)
- 25 Subject to paragraph (2) of this subsection, the Secretary

- 1 may expedite hiring of post-secondary students under sec-
- 2 tion 3116 of title 5, without regard to subsection (d) of
- 3 such section or any regulations prescribed by the Office
- 4 of Personnel Management for administration of such sub-
- 5 section.
- 6 "(2) The number of employees the Secretary may ap-
- 7 point under section 3116 of title 5 may not exceed the
- 8 number equal to 25 percent of the number of students
- 9 that the Secretary appointed during the previous fiscal
- 10 year to a position at the GS-11 level, or an equivalent
- 11 level, or below.
- 12 "(h) Pay Authority for Critical Positions.—
- 13 (1) Subject to the provisions of this subsection, the Sec-
- 14 retary may authorize the fixing of the rate of pay for a
- 15 critical position in the Department consistent with the au-
- 16 thorities and requirements of section 5377 of title 5 that
- 17 apply to the Office of Personnel Management.
- 18 "(2) The Secretary may fix the rate of pay for a crit-
- 19 ical position under this subsection in excess of the limita-
- 20 tion set forth by section 5377(d)(2) of such title.
- 21 "(3) Basic pay may not be fixed under this subsection
- 22 at a rate greater than the rate payable for the Vice Presi-
- 23 dent of the United States established under section 104
- 24 of title 3, except upon written approval of the President.

- 1 "(4) Notwithstanding section 5377(f) of title 5, the
- 2 Secretary may authorize the exercise of authority under
- 3 this subsection with respect to up to 200 positions at any
- 4 time.
- 5 "(i) RATES OF SPECIAL PAY.—(1) The Secretary
- 6 may establish a rate for special pay under section
- 7 5305(a)(1) of title 5.
- 8 "(2) In applying such section to the Secretary's au-
- 9 thority under paragraph (1)—
- 10 "(A) '50 percent' shall be substituted for '30
- 11 percent'; and
- 12 "(B) 'level II of the Executive Schedule' shall
- be substituted for 'level IV of the Executive Sched-
- 14 ule'.
- 15 "(j) Waiver of Limitations on Certain Pay-
- 16 MENTS UNDER PAY COMPARABILITY SYSTEM.—The Sec-
- 17 retary may waive the limitation in section 5307 of title
- 18 5 for an employee or a payment.
- 19 "(k) TERMINATION.—The authorities under this sec-
- 20 tion shall terminate on September 30, 2027.".
