H.R. 185 - To terminate the requirement imposed by the Director of the Centers for Disease Control and Prevention for proof of COVID-19 vaccination for foreign travelers, and for other purposes

H.J. Res. 24 - Disapproving the action of the District of Columbia Council in approving the Local Resident Voting Rights Amendment Act of 2022

H.J. Res. 26 - Disapproving the action of the District of Columbia Council in approving the Revised Criminal Code Act of 2022

1. Structured rule for H.R. 185.
2. Provides one hour of general debate equally divided and controlled by the chair and ranking minority member of the Committee on Energy and Commerce or their respective designees.
3. Waives all points of order against consideration of the bill.
4. Provides that the bill shall be considered as read.
5. Waives all points of order against provisions in the bill.
6. Makes in order only those further amendments printed in the Rules Committee report. Each such amendment may be offered only in the order printed in the report, may be offered only by a Member designated in the report, shall be considered as read, shall be debatable for the time specified in the report equally divided and controlled by the proponent and an opponent, shall not be subject to amendment, and shall not be subject to a demand for division of the question.
7. Waives all points of order against the amendments printed in the report.
8. Provides one motion to recommit.
9. Closed rule for H.J. Res. 24.
10. Provides one hour of general debate equally divided and controlled by the chair and ranking minority member of the Committee on Oversight and Accountability or their respective designees.
11. Waives all points of order against consideration of the joint resolution.

12. Provides that the joint resolution shall be considered as read.
13. Waives all points of order against provisions in the joint resolution.
14. Provides that pursuant to section 604(h) of the Home Rule Act, a motion to recommit is not in order to the joint resolution if under consideration while the act of the D.C. Council is within the congressional review period prescribed in section 602 of such Act.
15. Closed rule for H.J. Res. 26.
16. Provides one hour of general debate equally divided and controlled by the chair and ranking minority member of the Committee on Oversight and Accountability or their respective designees.
17. Waives all points of order against consideration of the joint resolution.
18. Provides that the joint resolution shall be considered as read.
19. Waives all points of order against provisions in the joint resolution.
20. Provides that pursuant to section 604(h) of the Home Rule Act, a motion to recommit is not in order to the joint resolution if under consideration while the act of the D.C. Council is within the congressional review period prescribed in section 602 of such Act.

RESOLUTION

Resolved, That at any time after adoption of this resolution the Speaker may, pursuant to clause 2(b) of rule XVIII, declare the House resolved into the Committee of the Whole House on the state of the Union for consideration of the bill (H.R. 185) to terminate the requirement imposed by the Director of the Centers for Disease Control and Prevention for proof of COVID–19 vaccination for foreign travelers, and for other purposes. The first reading of the bill shall be dispensed with. All points of order against consideration of the bill are waived. General debate shall be confined to the bill and shall not exceed one hour equally divided and controlled by the chair and ranking minority member of the Committee on Energy and Commerce or their respective designees. After general debate the bill shall be considered for amendment under the five-minute rule. The bill shall be considered as read. All points of order against provisions in the bill are waived. No amendment to the bill shall be in order except those printed in the report of the Committee on Rules accompanying this resolution. Each such amendment may be offered only in the order printed in the report, may be offered only by a Member designated in the report, shall be considered as read, shall be debatable for the time specified in the report equally divided and controlled by the proponent and an opponent, shall not be subject to amendment, and shall not be subject to a demand for division of the

question in the House or in the Committee of the Whole. All points of order against such amendments are waived. At the conclusion of consideration of the bill for amendment the Committee shall rise and report the bill to the House with such amendments as may have been adopted. The previous question shall be considered as ordered on the bill and amendments thereto to final passage without intervening motion except one motion to recommit.

Sec. 2. Upon adoption of this resolution it shall be in order to consider in the House the joint resolution (H.J. Res. 24) disapproving the action of the District of Columbia Council in approving the Local Resident Voting Rights Amendment Act of 2022. All points of order against consideration of the joint resolution are waived. The joint resolution shall be considered as read. All points of order against provisions in the joint resolution are waived. The joint resolution shall be debatable for one hour equally divided and controlled by the chair and ranking minority member of the Committee on Oversight and Accountability or their respective designees. The previous question shall be considered as ordered on the joint resolution to final passage without intervening motion except one motion to recommit (if otherwise in order).

Sec. 3. Upon adoption of this resolution it shall be in order to consider in the House the joint resolution (H.J. Res. 26) disapproving the action of the District of Columbia Council in approving the Revised Criminal Code Act of 2022. All points of order against consideration of the joint resolution are waived. The joint resolution shall be considered as read. All points of order against provisions in the joint resolution are waived. The joint resolution shall be debatable for one hour equally divided and controlled by the chair and ranking minority member of the Committee on Oversight and Accountability or their respective designees. The previous question shall be considered as ordered on the joint resolution to final passage without intervening motion except one motion to recommit (if otherwise in order).

1. McGovern (MA)	#15 Clarifies that this legislation will not affect the authority of the Centers for Disease Control and Prevention to mandate vaccination requirements against any other disease in the future for noncitizens who are nonimmigrants entering the U.S.	(10 minutes)
2. Boebert, Lauren (CO)	#10 Requires CDC to produce a report to Congress on the number of visitors denied entry under this policy.	(10 minutes)
3. Perez, Marie Gluesenkamp (WA), Golden (ME)	#9 Eliminates the prohibition on future rulemaking.	(10 minutes)
4. Rose, John (TN)	#17 Clarifies that nothing in the underlying bill impacts the CDC order requiring a pre-departure COVID-19 test for people traveling from the People's Republic of China.	(10 minutes)
5. Torres, Norma (CA)	#13 Requires the Secretary of the Department of Health and Human Services to certify that such provision will not result in an increase in hospitalizations due to COVID-19 prior to the provisions of section 1 taking effect.	(10 minutes)
